REAC Inspection

I am happy to report that overall our August HUD REAC inspections went very well.

The inspector pointed out a few items that we will be addressing during future inspections:

If a room has only one exit outside (Ex: bedroom window) – that exit must not be blocked by furniture.

Doors must be able to latch & if it has a lock the lock must work.

Emergency Alarm pulls must be accessible to a person lying on the ground. I will be checking this closely during future inspections

Windows must open and close

I will send out reminders prior to inspections but these items will be a priority for me.

Halstead Housing Authority News

- The Smoke-Free Policy became effective September 1, 2013. Thank you for your feedback & cooperation with this change!
- Parking Lot Striping: We are currently accepting bids for parking lot striping. The board will select the contractor to complete the project at the October 2013 board meeting. We will be making a few small changes to comply with ADA regulations. We will have our lots power washed prior to striping & Nikki will keep tenants informed of dates and parking arrangements that will be necessary via memo.
- Roofing & Repairs: The housing authority will be undergoing roof replacement in the near future as well as repairs to fascia & gutters. During the September board meeting, the board accepted all bids submitted by Mid-Kansas Construction for roof replacement. We will be working closely with contractors to set dates for project completion & tenants will be notified when dates are set.
- Admission & Continued Occupancy Policy is currently being updated & revised. The board will review the policy updates at the October board meeting. Tenants will be given the opportunity to review changes and provide feedback prior to the November board meeting.

Quick Oatmeal Cookies (No Bake)

Ingredients:

2 c Sugar

3/4 c Butter

½ c Milk

3/4 c Peanut Butter

4 c Oatmeal

1 tsp Vanilla

½ c Pecans (optional)

Mix together sugar, butter, & milk. Boil 1 minute. Add peanut butter. Stir in oatmeal & pecans. Drop by spoonful on waxed paper.



Frozen Fruit Slush

Ingredients:

1-12 oz can Frozen lemonade

1-12 oz can Frozen orange juice

2-10 oz cans Frozen sliced strawberries

1-20 oz can Crushed pineapple

1 sm bottle Maraschino cherries

5 sm Bananas (sliced)

2 ½ c Water

1 c Sugar

Mix all ingredients in a large container. Place in freezer for 6 hours, stirring often until slushy or freeze until hard. If frozen, let stand at room temp for 20-30 minutes until slushy before serving.
