What is a REAC Inspection?

REAC stands for **Real Estate Assessment Center.** REAC is operated by the US Dept. of HUD.

Halstead Housing Authority receives funding through the US Dept. of HUD subsidies & capital fund program. That is how we are able to offer housing to tenants based on their income.

In order for HUD to ensure that families living in public housing live in "decent, safe, and sanitary" conditions as well as live in property that is in "good repair". "REAC conducts approximately 20,000 physical inspections on properties each year."

The inspections may be scheduled every year, every other year, or every three years. Our last inspection was conducted in July 2011.

REAC Inspectors are contracted by HUD to inspect all landscaping & grounds, as well as inside & outside of any building & dwelling unit operated by the Housing Authority.

In order to prepare for our upcoming inspection, we scheduled pre-inspections at the beginning of July. Dates & times are listed on page 2.

Tenants can help us prepare for the REAC inspection by keeping your unit clean, making sure that entrances & windows are not blocked, and notifying the office with any maintenance request if you have anything in your unit needing repaired.

Halstead Housing Authority News

- New window treatments were installed on the clerestory windows at Sunflower Heights this spring.
- Trees were trimmed in Meadowlark, Sunflower, & Cottonwood
- Buffalo grass was spread over the grounds at Sunflower Heights in May
- A utility analysis was conducted this spring in Sunflower Heights & Meadowlark. Tenants will be notified in June about changes in utility allowance amounts.
- We have been working to improve the landscaping around the Community Building & Pergola on Cottonwood Acres grounds. A few of the plants around the pergola will be planted in the fall due to lack of seasonal stock. We also replaced plants at Meadowlark that were a part of the original landscaping.
- A new "Smoke-Free Policy" was posted for review and will be voted on at the June 19, 2013 Board Meeting.
- We will be replacing windows in 4 apartments at Meadowlark in July

Secret Surprise Zucchini Cobbler - (Tastes even better with a scoop of vanilla ice cream)

Ingredients:

- 8 cups chopped seeded peeled zucchini
- 2/3 cup lemon juice
- 1 cup sugar
- 1 teaspoon ground cinnamon
- 1/2 teaspoon ground nutmeg
- CRUST:
- 4 cups *all-purpose flour*
- 2 cups sugar
- 1-1/2 cups *cold butter*, *cubed*
- 1 teaspoon ground cinnamon



Directions:

In a large saucepan over medium low heat, cook & stir zucchini & lemon juice for 15-20 minutes until zucchini is tender. Add the sugar, cinnamon & nutmeg; simmer 1 minute longer. Remove from heat; set aside.

For crust: combine the flour & sugar; cut in butter until the mixture resembles coarse crumbs Stir ½ cup into zucchini mixture. Press half of remaining crust mix into a greased 15x10x1 pan. Spread zucchini over top; crumble remaining crust mix over zucchini. Sprinkle with cinnamon. Bake 375° for 35-40 min.

Serve warm!
